Country : INDIA – Update 24

Dear Valued Customers,

We refer to our earlier Customer Advisory released on 30th June, 2020 and the emerging situation in India due to COVID-19 regulations and would like to keep our customers updated of the latest situation.

- As coronavirus cases continued to surge, some States have extended the shutdown to control the further spread. While few States opted for 30 days shutdown, some States, especially in the northeastern region chose 15-days lockdown.
- Maharashtra Govt has extended the lockdown for the State to 31st July 2020. The Government has issued fresh guidelines under *Mission Begin Again*, stating that the movement of non-essential activities will be restricted.
- Tamil Nadu Govt has also extended lockdown in the State till 31st July 2020 to contain the further spread of coronavirus. But the total lockdown at Chennai has been withdrawn, effective 06th Jul, 2020.
- West Bengal Govt has also extended the lockdown in the State till 31st July 2020.

ONE India updates as below:

- 1. ONE India offices, including doc counter remain open with reduced staff strength, on all days. Rest of the staff working from home.
- 2. Details of Office & Doc counter working days/ working hours are available in the location wise update table, which is shared below. Requesting our customers to refer the same.
- For all our eCommerce Services, business will be as usual viz. E-Booking, E-Bills of Lading, E-Delivery Order, E-Invoicing and E-payment. Requesting our customers to use all our eCommerce products.
