<b>Export Detention Count Rule :</b>
<a href="#">For Gateway Ports / ICD Locations</a>

For Laden Containers : Container detention free time calculation starts from the day the empty container is picked up from the yard or CFS till the day the laden container is gated in at port or ICD point.

For Empty Containers : Zero free days in case of empty return of containers. Detention charges applicable from the date of pick up till the date of empty container return, alongwith booking cancellation fee.
